

Request for Proposal USDA, Emergency Rural Health Care Grant Program

Background. San Luis Valley Health (SLVH) was awarded a United States Department of Agriculture (USDA), Emergency Rural Health Care Grant to renovate SLVH hospital rooms in its Regional Medical Center (RMC), located in Alamosa, Colorado. SLVH has requested Use of an Alternative Delivery Process using the Construction Manager as constructor (CMc) method. This method will be advantageous to SLVH, offering pre-construction services that will address scheduling constraints and ensure the project meets budget. SLVH is currently soliciting the CMc through a Request for Proposal (RFP) process to maximize open and free competition. Scope of Work. This project will convert five rooms, currently used for SLVH's cardiology clinic and cardiopulmonary outpatient services, into patient care rooms. Previously, these rooms and associated nursing station were used as an inpatient wing. The existing footprint from this past use will allow SLVH to retro fit these rooms back to inpatient rooms. These private rooms will be flexible to accommodate the need for isolation when required for COVID positive patients, as well as for high acuity patient care on demand. The total square footage of the five combined patient care rooms is 1,515. The total square footage of the entire scope of work to include corridors and med/surg support and staff areas is 3,623. Rooms will be updated with new flooring, LED replacement lighting, air scrubbers, furnishings and equipment, medical gas headwall improvements, and necessary technology updates, to operate updated equipment and support patient monitoring and staff work locations. The update will include a patient care room bathroom to meet current ADA/ABA standards. The unit currently has a nursing station that will need new nurse station casework, a secured medication room, Pyxis machine, refrigerator, and CII safe. Aesthetics (flooring, paint, wall protection) within the unit will be updated to match other units within the hospital to visually unify locations.

Service Agreement. The selected CMc will be required to execute a service agreement utilizing the AIA A133 – 2019 Standard Form of Agreement Between Owner and Construction Manager as CMc where the basis of payment is the Cost of the Work Plus a Fee with a Guaranteed Maximum Price, as modified by USDA funding requirements.

Rough Order of Magnitude. This project will convert five rooms, currently used for SLVH's cardiology clinic and cardiopulmonary outpatient services, into patient care rooms. The estimated budget is between \$2.5 and \$3.5M.

- 3. Plan/Procedure to Comply with Hospital Flu and COVID Vaccination Protocols (Max 1 page)
- 4. Summary Statement of Qualifications and Statement of Understanding of Scope of Work (Max 2 pages)
- 5. Description of Technical Approach and Management Plans (Max 2 pages)
- 6. Quality Assurance/Quality Control Plan (Max 1 page)
- 7. Project Time/Activity Schedule Chart/Table with Narrative (Max 2 pages)
- 8. Names, Brief Bios, Qualifications, and/or Certificates of all Individuals. LEED experience and Value-engineering desirable (Max 1 page per individual)
- 9. Project Participant Organizational Chart (Max 1 page)
- 10. Project Specific: Specialized Experience and Technical Competence with CMc Projects (Max 2 pages)
- 11. Relevant Rural, Colorado, Construction Experience (Up to 5 projects in the last 10 years, including currently. Max 2 pages per project.)
- 12. Evidence of Staying Current with Construction industry innovations and Codes: Continuing Education, Attendance at industry Conferences/Trade shows (Max 1 page)
- 13. Customer Rating, Feedback, Testimonials, Awards, etc. (Max 3 pages)

- 14. Corporate Capability Provision of evidence of necessary software (project tracking, billing, CAD 2018 or newer), financing, bonding, equipment/machinery, facilities, expertise, available personnel time. (Max 2 pages)
- 15. Appendices, Insurances (Max 3 pages)
- 16. Knowledge and Implementation of Infection Control/Risk Assessment and Interim Life Safety Measures (ICRA and ILSM) (Max 2 pages)
- 17. Care taken and emphasis on quality in preparing proposal package
- 18. Proposed Fee for Pre-Construction Phase / CMc Services
- 19. Confirmation of Receipt of all RFP Addenda

Proposals will be objectively evaluated and scored based on the above elements. The first three elements must be met for eligibility and further consideration. Proposals will remain valid for 30 days.
